Definitions and Abbreviations

Action Level:

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements

Action Level Goal (ALG):

The level of a contaminant in drinking water below which there is no known or expected risk to

health. ALCs allow for a margin of safety

Average:

Regulatory compliance with some MCls are based on running annual average of monthly samples

Level 1 Assessment:

A study of the water system to identify potential problems and determine (if possible) why total

coliform bacteria have been found in our water system.

Level 2 Assessment:

Is a very detailed study of the water system to identify potential problems and determine (if possible) why an E-coli MCL violation has occurred and/or why total coliform bacteria have been found in appropriate and the detailed and the system of the syst

found in our water system on multiple occasions.

Max Contaminant level or MCL:

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the

MCLGs as feasible using the best available treatment technology.

Max Contaminant level goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Max residual disinfectant level or MRDL:

The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Max residual disinfectant level goal or MRDLG:

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Million fibers per liter (a measure of asbestos)

mrem:

millirems per year (a measure of radiation absorbed by the body)

NTU:

Nephelometric Turbidity Units (a measure of turbidity)

PCI/L

picocuries per liter (a measure of radioactivity)
